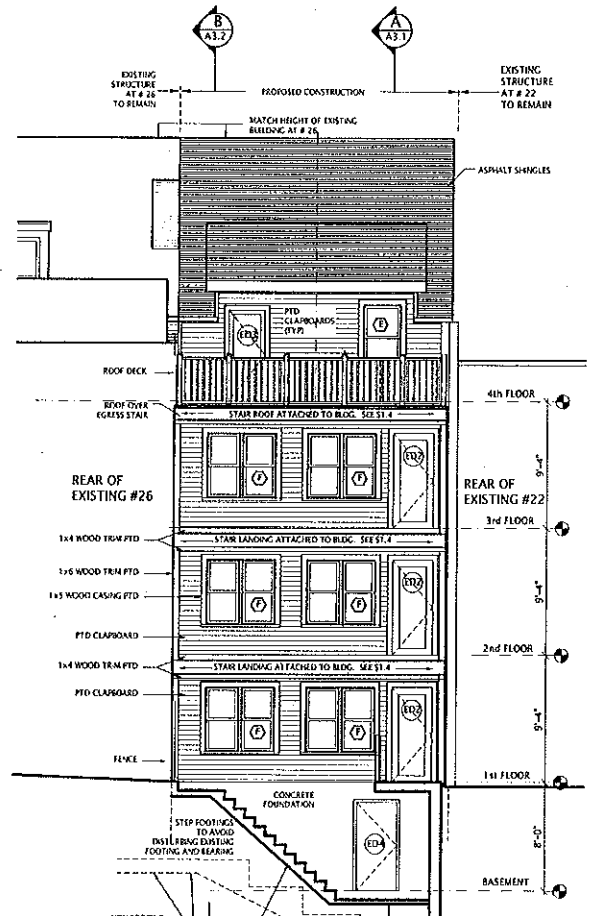
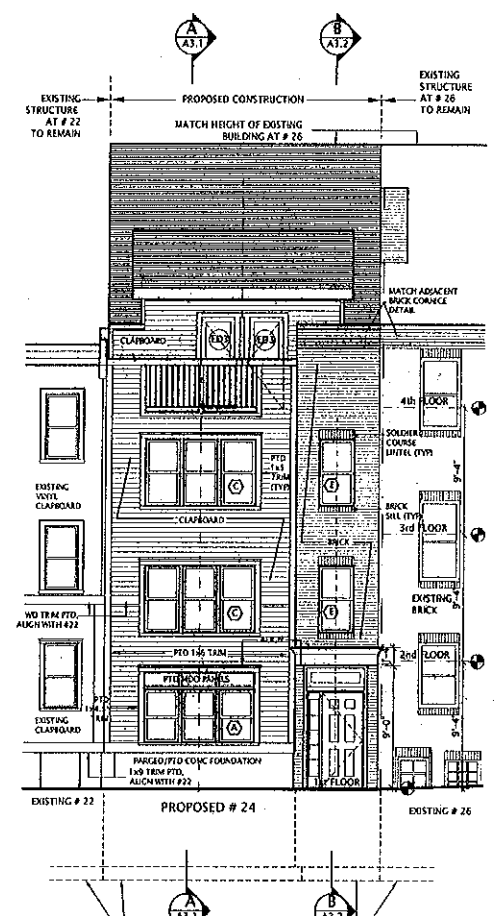


REAR STAIR ELEVATION

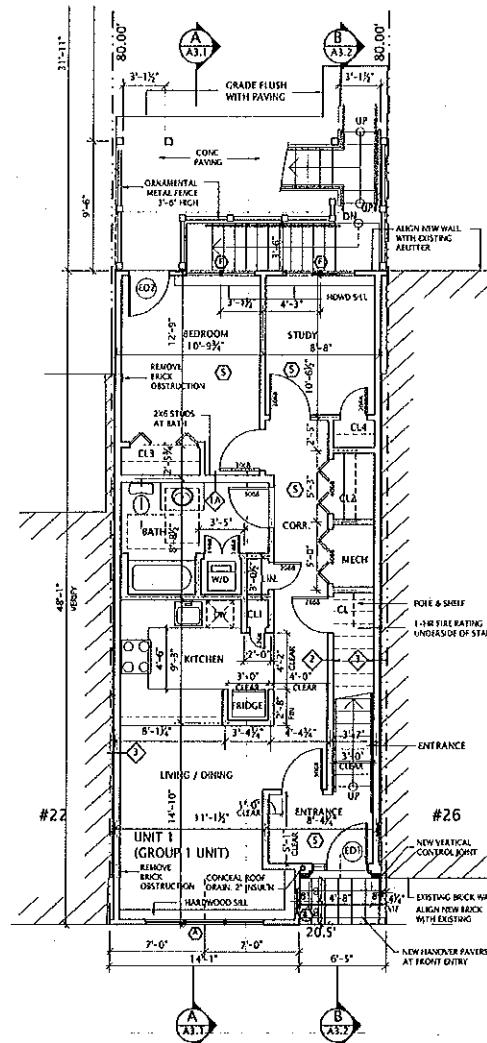

3. CONCRETE WALLS TO REMAIN UNFINISHED.

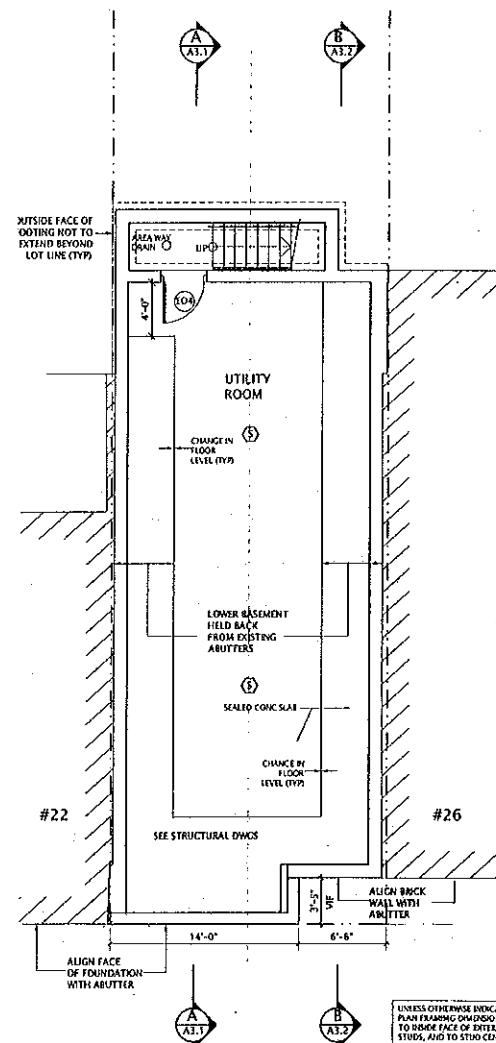

PLAN NOTES

1. UNLESS OTHERWISE INDICATED, PLAN FRAMING DIMENSIONS ARE TO INSIDE FACE OF EXTERIOR STUDS, AND TO STUD CENTERLINE OF INTERIOR PARTITIONS. PROVIDE CLEAR FINISH DIMENSIONS WHERE INDICATED.
2. ALL PARTITIONS SHALL CONTINUE TO UNDERSIDE OF FLOOR ASSEMBLY ABOVE. ALL FIRE SEPARATION WALL ASSEMBLIES SHALL CONTINUE TO UNDERSIDE OF FLOOR DECK ABOVE.
3. ALL SHAFT WALLS SHALL BE CONTINUOUS BETWEEN FLOORS AND SHALL BE SEALED AIRTIGHT.
4. ALL WEATED ASSEMBLIES SHALL BE CONTINUOUS AND SHALL NOT BE INTERRUPTED AT AN INTERSECTION WITH OTHER ASSEMBLIES.
5. MOISTURE RESISTANT GWS SHALL BE USED BY ALL BATHROOM WALLS AND CEILING, EXCEPT AT LOCATIONS TO RECEIVE TIE, WHICH SHALL HAVE CEILING TIE BACKER BOARD.
6. ALL GROUP 1 UNITS SHALL CONFORM WITH THE REQUIREMENTS OF 521 CMR ARCHITECTURAL ACCESS REQUIREMENTS.
7. AT GROUP 1 UNITS, PROVIDE BLOODING IN WALLS FOR FUTURE INSTALLATION OF GRAB BARS AT TOILETS, BATHFELS AND SHOWERS. GRAB BARS SHALL BE CAPABLE OF SUPPORTING A PERSON 250 LB VERTICAL LOAD.
8. AT GROUP 1 UNITS, PROVIDE LAVATORIES WHICH ARE CAPABLE OF BEING RELOCATED VERTICALLY. CABINETS UNDER LAVATORIES SHALL BE CAPABLE OF BEING REMOVED.
9. AT GROUP 1 UNITS, KITCHEN BASE CABINETS SHALL BE CAPABLE OF BEING REMOVED. BASE CABINETS AT SINKS SHALL BE REMOVABLE AND CAPABLE OF PROVIDING A KNEE SPACE OF 30" WIDE.
10. AT GROUP 1 UNITS, ALL DOOR HARDWARE SHALL BE LEVER TYPE.
11. PROVIDE SMOKE ALARM SYSTEM IN CONFORMANCE WITH THE STATE BUILDING CODE AND ALL LOCAL ORDINANCES.

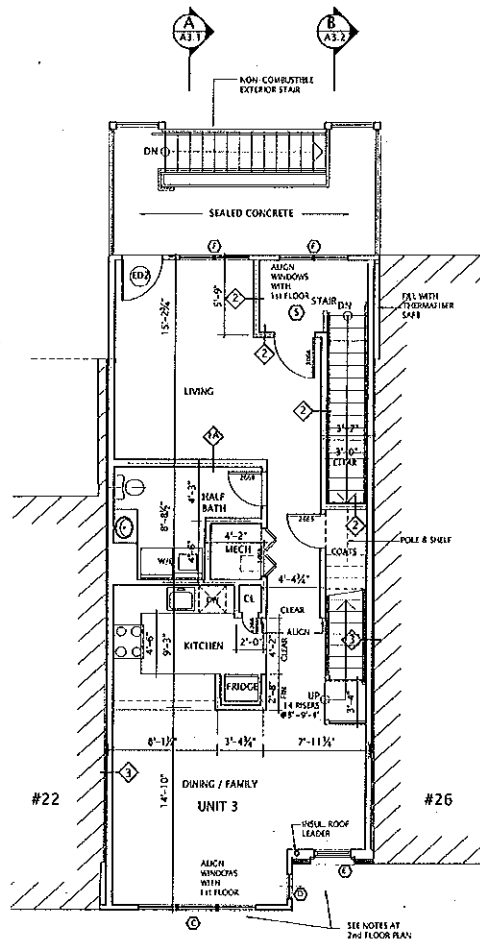
BASEMENT PLAN

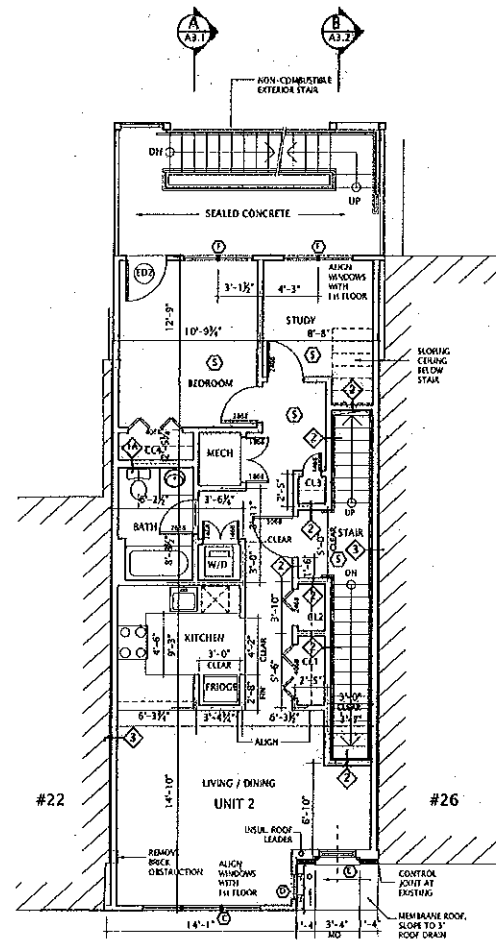
PLAN NORTH

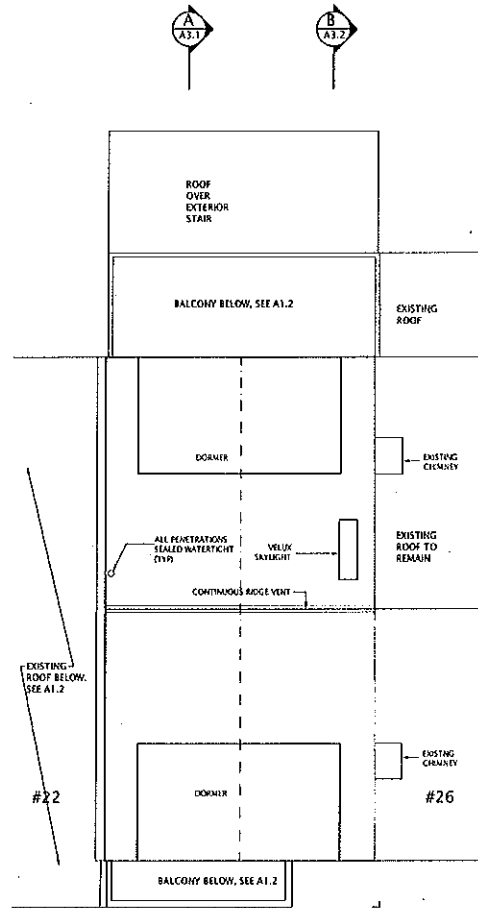
2nd FLOOR PLAN

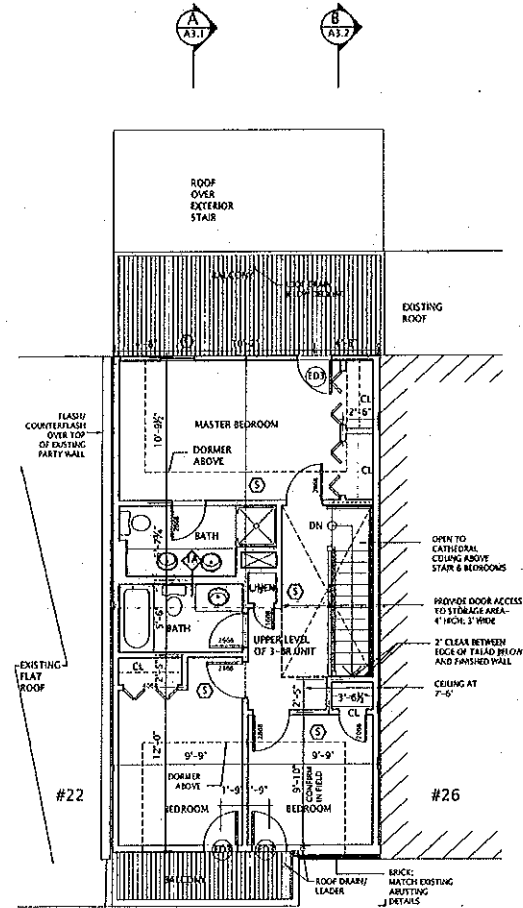
